The checks are part of a \$2 trillion relief package aimed to buoy the economy through the coronavirus pandemic. The checks will be worth up to \$1,200 per adult and \$2,400 per jointly filing couple. Families will also get \$500 per child. You must have a Social Security Number to get a check. The amount you get is based on your adjusted gross income (line 8b on your 2019 1040 form, or line 7 on your 2018 1040). If your AGI is more than \$75,000 per child. year (or \$150,000 per couple), you'll get less than \$1,200.
