[7] In the investigations conducted on the workers of the Vietnamese-American nail salon, many answers suggested that the work environment can cause negative health consequences. According to Standard 62-1989: ventilation for the acceptable indoor quality of the American company for heating, refrigeration, air conditioning engineers, adequate adequate of external air should be about 20 cubic feet per minute per occupant. This requires multiple routes for the air to enter and exit the room. These paths include, but are not limited to, windows and doors. The study revealed that a third of the beauty salons interviewed had only one door for ventilation without secondary airway. [1] Due to the nature of the work salon, many nail technicians are required to wear masks and gloves. Other investigations on similar workers populations revealed that 90% of workers wore masks and 70% wore work gloves. [8] common responses by workers interviewed included: [8] "We know that chemicals are dangerous, the owner tells us about wear mask" "says that chemicals are harmful always need to keep the fan and close the lids, covers of chemicals surely." "Because I'm young and pregnant and I don't want to breathe in powder and chemicals a fear that could affect my baby later on" Chemical Manicure exposures use beauty products such as nail polish, artificial nails, stickers, and disinfectants throughout the day. Compared to the individual average, the chemical ingredients of the products contain on a much higher magnitude. Some of the most powerful chemicals are toluene, formaldehyde, etil metacrilate (EMA), [9] and dibutylfthalate (DBP). [10] Almost all chemicals are reported to be eyes, skin, nose, throat and irritants. Some chemicals, such as phthalate toluene and dibutile, are known as endocrine disruptors. According to the National Institute of Environmental Health Sciences (NIEHS), endocrine interferers are chemicals that interfere with the endocrine system, which is regulated by hormones. These hormonal disruptors can potentially lead to tumors, birth defects, reproductive, neurological, development, and immune degradation. Research has suggested that endocrine interfering pose greater risks during prenatal and postnatal development. [11] The table below is taken from the survey The results of an Occupational Health Survey of Vietnamese-American Nail Salon workers based community. [8] It lists the chemical ingredients present in the nail salon products and associates them with potential health effects. Relevant policy and regulations State level California Safe Cosmetics Act of 2005 (SB484) ENATA in 2005, this law of the Senate requires the complete dissemination of all the ingredients of products sold in California to the California health department. Furthermore, if substances are known to cause cancer or reproductive damage, the products will be investigated by the Division Control of Environmental and Employment Diseases. [12] Proposition of California 65 (1986) ENATA in 1986, this proposal requires that California State publish a list of known chemicals to cause cancer, birth defects or other reproductive damage. All the Californian companies with ten or more employees must also provide a "clear and reasonable" warning before exposing any individual to a chemical in the list indicated above, [13] Federal Control Law of toxic substances of 1976 (TSCA) (15 USC Â§ 2601) ENA in 1976, this federal act provides the Agency for environmental protection (EPA) the authority to regulate some chemicals . [14] Currently, cosmetics are excluded from regulation under TSCA, but there have been campaign efforts that hope to extend the regulatory competence of the EPA to include cosmetics.
