MIPIM once again crucial for Plac Unii Liebrecht & wooD and BBI Development signed investment agreement

Warsaw, 18 March 2010 – Developers Liebrecht & wooD and BBI Development signed investment agreement for Plac Unii. In accordance with the agreement both partners will invest in the project around 155 millions PLN. Liebrecht & wooD takes over the majority package and will contribute from 80 to 90 million PLN to the project and will purchase part of the BBI Development shares for 12.5 millions PLN. Agreement came along with a project presentation at this year's MIPIM fairs in Cannes, where a year ago, both developers made the decision to start cooperation re. Plac Unii.

Negotiations started in July 2009, when preliminary agreement were signed between two developers. Project's due diligence ended positively in November 2009. Since signing the preliminary agreement Liebrecht & wooD invested about 6.8 millions PLN in the project. Construction works are planned for II and III quarter of 2010.

Liebrecht & wooD will obtain, after the final shareholding structure is achieved, 52 percent of shares in the project and BBI Development - 48 percent, and after purchasing part of the shares from BBI Development: 60 percent and 40 percent respectively.

Signing the investment agreement lasted almost a year after the decision about starting the cooperation re. Plac Unii project, which happened during MIPIM 2009. Also on real estate fairs in Cannes this year, one of the most prestigious in the real estate world, Plac Unii will be presented again but this time as a project of two investors, whose have the


